understand and agree that the USAV IMPACT Manual is **COPYRIGHTED MATERIAL** with **ALL RIGHTS RESERVED**. Even when posted to the National Office website for Instructors and ROD personnel, this material is **NOT** part of the public domain.

By signing and returning this Material Use Agreement, I understand and agree that:

1. Before receiving the rights to copy the IMPACT Manual and use the IMPACT materials for its certified Instructors and approved IMPACT or IMPACT Plus Clinics, Regions must sign and return a copy of this **IMPACT Materials Use Agreement**, along with the annual \$100 fee.
2. This **Use Agreement** stipulates that each Region may provide the **electronic version** of such materials ONLY to it's Education staff for preparation/printing for Region IMPACT Clinics and to certified Master IMPACT Instructors and IMPACT Clinicians, and may NOT provide such materials in electronic form to any other RVA member, or member of the public at large.
3. No part of this work may be reproduced, transmitted, shared or posted to the world wide web in any form or by any means, electronic or mechanical, including photocopying and recording, or by any information storage or retrieval system, except as may be expressly permitted by the 1976 Copyright Act, and with permission **in writing** from USA Volleyball.
4. **NO** IMPACT material (to include the manual, power point, instructor resources, etc. in their entirety or any portion of) may be posted electronically for free downloading by the public or by USAV Region members, or distributed electronically via CD or DVD or email, etc. except with express written permission by the National USAV Office. **Requests for such permission should be expressed in writing to the USA Volleyball Coaching Education Department.**
5. **EVERY IMPACT Clinic attendee should receive his/her own printed copy of the current year IMPACT Manual (11 Chapters) at their on-site course.** This means that the **PRINTED** version of the **IMPACT Manual** is to be distributed to IMPACT Clinic attendees as part of their Clinic materials received for their attendance fee, or provided free to them at the Region's cost.
6. To that end, this agreement grants the above named USAV Region the right to reproduce the IMPACT Manual (and Power Point Presentation slides for note-taking purposes) in **PRINTED** form to distribute to IMPACT Clinic attendees as part of the clinic materials. **The printed IMPACT Manual or PowerPoint presentation is not to be sold for commercial purposes.**
7. Region Offices, RVA Education staff and/or authorized IMPACT Clinicians may download the master copy of the current year manual from the respective ROD or IMPACT Instructor restricted pages of the USAV National website (or from a CD/DVD distributed by the National office for such purposes) for printing the clinic Manuals locally, or have the option of ordering the pre-printed Manuals at a nominal cost using the order form provided - in a 3 ring binder as in the past from the USAV-CAP office in Colorado Springs, or as an alternate as a print-on-demand soft cover book from the provider listed on the Order Form. **Reproduction for all other uses must be pre-approved in writing by the USAV National Education Office.**
